

Board Minutes Lakes Region Public Access Television Meeting Tuesday, March 28, 2023, 3:00 PM In-person and over Zoom

Roll Call:

A. MacRae called the March 28, 2023 LRPA board meeting to order at 3:02 PM and proceeded with roll call; attendance as noted above.

Approval of March 7, 2023 Minutes:

MacRae asked for any additions, corrections or deletions to the minutes of 03-07-23. Hearing none, MacRae called for a motion to approve meeting minutes as presented. J. Landow made the motion, seconded by M. Haynes. The board approved the 03-07-23 minutes by roll call vote, with T. Brown abstaining.

Financial Report:

G. McNamara presented the financial report. As of 03/20/23, LRPA's cash balance is \$84,800.91; total YTD expenditures are \$44,748.02; savings account balance as of 12/30/22 is \$14,750.66. McNamara noted that Gunstock has already paid its Q1 invoice of \$825.00, sent out in the previous 10 days. MacRae called for a motion to approve the financial report as presented. Brown made the motion, seconded by N. LeRoy. The board approved the finance report by roll call vote.

Station Manager Report:

McNamara gave the station manager's report. She noted that the 2023-24 municipal membership packages are on track to be emailed out in the next few weeks. Late April through mid-June are busy weeks at the station and will include several live streamed and live-to-tape events around the Lakes Region. MacRae called for a motion to approve the station manager's report as presented. Landow made the motion, seconded by Haynes. The board approved the station manager's report by roll call vote.

Old Business:

Brief discussion on LRPA Annual Meeting

The board discussed the goals, format and potential guest list of the 2023 LRPA Annual Board meeting, scheduled for Tuesday, May 30, at 3:00 PM in the Armand A. Bolduc City Council Chamber at Laconia City Hall, 45 Beacon Street East. McNamara will follow up and report back at the April board meeting.
