Lakes Region Public Access Television Annual Meeting

Roll Call:

A. MacRae (filling in for T. Stafford) called the May 10, 2022 LRPA annual board meeting to order at 3:02 PM and proceeded with roll call; attendance as noted above.

Approval of January 25, 2022 Minutes:

As there was no quorum, approval of the 1/25/22 minutes was tabled until the LRPA board meeting of 6/28/22.

Nomination and Election of 2022-23 LRPA BOD Officers

As there was no quorum, nomination and election of 2022-23 LRPA board officers was tabled until the LRPA board meeting of 6/28/22.

Financial Report:

J. Beaudin presented the financial report. As of 5/10/22, LRPA's cash balance is \$88,787.39; total YTD expenditures are \$61,231.42; savings account balance as of 3/31/22 quarterly statement is \$20,108.03. G. McNamara added that as of 4/18/22, LRPA's loan balance is \$6,123.55. As there was no quorum, approval of the 5-10-22 financial report was tabled until the LRPA board meeting of 6/28/22.

New Business:

a). SM bookkeeper/check writing capabilities

b). Motorcycle Week Press Conferences

McNamara proposed that LRPA record the Pre-Motorcycle Week Press Conference of 6/9/22 (to be held at the Colonial in Laconia) but not stream or record the daily press conferences (6/13 - 6/16/22) at the Naswa Resort). The board agreed. McNamara will inform the directors of Motorcycle Week.

c) Discussion on returning to monthly board meetings

McNamara presented an updated board meeting schedule for FY 22-23 that includes returning to monthly board meetings with the exception of December, July and August. C. Eddy suggested moving

the meeting time from 3PM to 4PM; board members present agreed. All agreed to hold one final LRPA FY 21-22 board meeting, on 6/28/22 at 4:00 PM in the station.
